Our Residential Programs provide housing, individualized support, and supervision and training services to individuals with developmental and intellectual disabilities at our assisted living community in St. Cloud, Florida.

With activities assisting our residents to develop, maintain, and improve independent living skills such as personal health and hygiene, social and adaptive skills, and household management, each resident is encouraged in reaching his or her potential for personal and spiritual growth and independence. Our direct support professionals develop individual life skills plans, which provide opportunities for community integration and socialization including volunteer opportunities, shopping, recreation, social outings, and religious services.

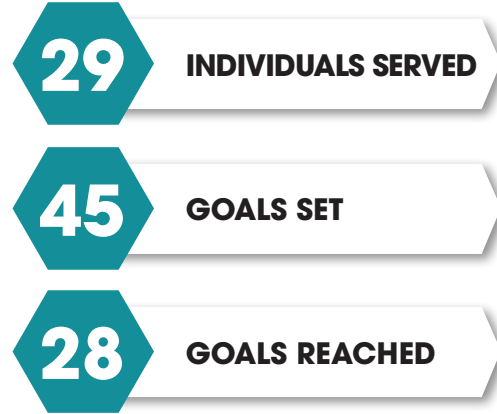

# Vocational Training Programs **Programs Highlights**

Our Vocational Training Programs are open to both residents of Bishop Grady Villas as well as those who reside throughout Central Florida, providing on-going educational activities for individuals with developmental and intellectual disabilities.

This program supports individuals to have meaningful and valued roles in the community and include topics in vocational development, social skills, physical fitness, and self-advocacy. These services are scheduled for six hours a day during the week, with activities including volunteer work, workplace job shadowing and tours, guest speakers from local employers, guest community instructors in art, etiquette, and exercise, and individualized activities to attain personal goals.

# Our Programs

## Employment Services



Our Employment Services Programs assists Osceola, Orange, Polk, and Seminole County jobseekers with disabilities in gaining employment. Our process consists of four components: Discovery, Preparation, Employment, and Follow-Along Support.

In the Discovery phase, we get to know the jobseeker through conversations with family, friends, and the jobseeker as well as various observational settings. Through this crucial first step in the process, we are able to develop a job skills and interest profile and resulting employment plan.

During Preparation, we assist individuals in applying for jobs and interviewing with employers in the community as well as the development of an employment strategy.

Once an individual is given an offer of employment, we act as a consultant for the employer and provide supplemental on-the-job-training as needed. Finally, after the new employee is stable in his or her job, our employment specialist continues to provide ongoing support to ensure that the employer and employee continue to flourish in their new partnership.

# Natasha

Natasha Fritz grew up dreaming of working in a school. Although her kind heart, loving spirit, and sense of humor endeared her to her teachers and classmates, her intellectual disabilities were always seen as a roadblock to competitive employment after graduation from high school. “There are not enough agencies to help people with cognitive disabilities find employment,” says Natasha’s mother, Anna Ruth Worten-Fritz. “We have been so blessed to have Bishop Grady Villas help us find the perfect job for Natasha, one where she can flourish and use her talents to the best of her abilities. I am so grateful for Bishop Grady Villas because I know someone is looking out for Natasha’s best interests.”

Bishop Grady Villas started working with Natasha on her employment goals in December of 2015, helping to identify her personal and vocational strengths as well as creating an employment plan and strategy. Within weeks Natasha was participating in a paid on-the-job training opportunity at Harmony High School, where she trained in the cafeteria learning food preparation, labeling, inventory, storage, and baking. As Natasha was set to graduate from high



school in December of 2015, Bishop Grady Villas negotiated the job training for a smooth transition from high school to paid training, with the goal of permanent employment. As a result, her self-confidence soared as she experienced the respect and camaraderie of co-workers for the very first time.

Bishop Grady Villas works with Osceola and Orange County schools, as well as the Division of Vocational Rehabilitation, to establish employment partnerships, internships, and paid on-the-job training opportunities for individuals with intellectual disabilities transitioning out of high school.

**“I love working in the kitchen, slicing the cheese, and helping with the dishes,” says Natasha. “My coworkers are nice to me and I do a good job.”**

In the spring of 2016, Natasha’s childhood dream came true. Her training ended in April 2016 and she was hired permanently in May 2016 at Harmony High School as a food service assistant. Natasha takes great pride in her duties of food preparation, keeping the cafeteria and kitchen orderly and neat, interacting with students, faculty, and staff, and maintaining a sanitary environment. “Natasha is a kind young woman who gets along with all her coworkers,” says Donna Meyers, Natasha’s supervisor. “She offers to help, does a good job, and is always willing to learn new things.”

## Carolina

Carolina was raised by a single mother in Colombia. She couldn't read or write and her mother, Olga, was frustrated that the local schools had failed her special-needs daughter. When Carolina was 11, mother and daughter decided to move to the United States to access better services and quality of life. Even though she didn't speak English or know a soul in the U.S., Olga felt confident that this is where God wanted them to be. Upon moving to Florida and enrolling Carolina in school, Carolina began to flourish. She learned to read, write, and speak English and quickly grew in her Catholic faith.

After Carolina graduated from high school, Olga was diagnosed with cancer. While her mom was fighting for her life, Carolina grew lonely and depressed, missing school and her friends and she became increasingly worried about her mother.



Upon touring Bishop Grady Villas, both Carolina and her mother knew immediately that it was the place where Carolina would be able to take her next step toward independence.

Because Bishop Grady Villas had a waitlist, Carolina couldn't move in immediately so she moved to a group home where she became even more unhappy. Finally, in June of 2015, Carolina moved to Bishop Grady Villas. She was thrilled! Carolina now has a great group of friends and they make plans like other young adults to go out to dinner or the movies. She joined Special Olympics and does her own shopping and chores. She is responsible for her own room and loves to take care of it with the assistance of the staff. Carolina's mom states that this is the first time in her daughter's life that she doesn't worry about her care or safety.

Most recently, Carolina became a team member at the Chick-fil-A in Celebration. Due to a new level of independence and vocational skills she has learned at Bishop Grady Villas, Carolina impresses her supervisor and co-workers every day. Her gorgeous smile is the brightest it's ever been.



# Zack



One of our newest and youngest residents, Zack, came to Bishop Grady Villas with a goal of working at Universal Studios. Motivated to find a job since his first day on campus, Zack was thrilled to be able to attend Adult Day Training (ADT) classes, learning not only vocational skills, social etiquette, and independent living skills, but also job interview techniques and how to work as part of a team.

Zack practiced his interviewing skills daily both at ADT as well as with his job coach. In class, he learned about the responsibility required to hold down a job as well as the importance of hard work, integrity, and honesty in the workplace.

In addition to class time, Zack also went on several practice interviews sponsored by the Kissimmee Chamber of Commerce and the Osceola School District. After each interview, Zack learned a little more and invested more in the job seeking process.

In January 2017, Zack was hired as a busser at Universal Studios' Mel's Drive-In and his mother has noticed a marked difference in his maturity and sense of responsibility. Meanwhile, Zack is grateful for the preparation and guidance offered to him through ADT. Due to the care and instruction from his teachers and encouragement from his classmates, his Universal dream came true.

When asked by his new supervisor what his hometown was to be listed on his Universal nametag, Zack, whose family lives in Jupiter, Florida, eagerly insisted on St. Cloud.

**“Bishop Grady Villas is my home,” says Zack. “I don’t want to be anywhere else.”**

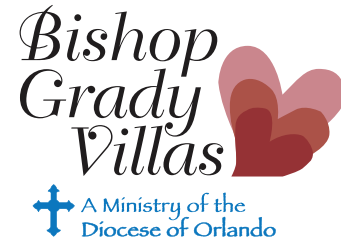
