




### Statistics for the Diocese of Orlando

- There are **198** permanent deacons serving in the Diocese of Orlando, and **33** men in formation to be ordained as deacons.
- More than **10,000** people visited the 200-acre San Pedro Spiritual Development Center last year and one-half of these attended a retreat or educational program of our diocese.
- There are **63** women religious serving in the Diocese of Orlando.
- **473** catechumens participated in the Rite of Chrisitian Initiation of Adults (RCIA) and were welcomed into the Church.

- 23 seminarians are in formation for their vocation to the priesthood, and
  2 were ordained to the priesthood.
- More than 1,700 teachers and staff in our Catholic schools are enriched by opportunities for formation so that 14,829 students are nourished by the gifts of God, His Word and His Body.
- Catholic Charities of Central Florida is our outreach to the people of God through the corporal works of mercy. More than **100,000** were served and more than **10 million** pounds of food were distributed.


